### **Getting Started**

This Rental Application is the first step in renting a home from Oklahoma Property Network. We request that you fill this form out completely, accurately and truthfully. Each adult living in the household should fill out a separate application. If you need additional applications you may copy this one or contact us for additional copies.

### **Submitting Your Application**

When you have completed your application, please contact us so that we may schedule a meeting to collect your application. Please bring the following to the meeting:

- Completed application
- Driver license or other government issued ID (photocopy appreciated)
- Verification of the last 2 months income (photocopy appreciated)
- Application fee (\$20)

Your application will not be considered complete unless all information is provided.

### **Response**

Once we receive your application, we will start processing. We typically complete this process within 3 business days. If we receive multiple applications we will process them in the order received.

If you are approved, you will be contacted and offered a chance to accept. To confirm your acceptance you must do the following within 5 days:

- Provide first months rent
- Provide security deposit
- Sign a rental agreement starting immediately

If you are declined we will contact you and let you know. In some cases when you do not meet our minimum requirements we may offer you an approval on an alternate property, approval with a higher deposit, or approval with a higher rental rate.

If you are declined or do not accept an offer to rent then we will file your application and process the next application that was received.

## Frequently Asked Questions

### **What if I have bad credit?**

*We do not expect your credit report to be perfect.* We use your credit report to provide information about your financial history and to verify the information in your application. We look at many factors when evaluating you as a prospective tenant.

### **Will you approve my application?**

Our criteria for each rental property vary. Generally we are looking for tenants who are responsible, will pay rent on time and will take care of the rental property. In return we look forward to providing quality housing in good repair that you would be proud to call home.

Following are some items that we will consider when reviewing your application:

- Ability to pay rent
- Income stability
- Rental history
- Employment history
- Personal references
- Accuracy, completeness and truthfulness of application

We do not pick and choose applicants. We accept the first applicant that meets our minimum criteria. *The sooner you apply the better your chances* are of being accepted.

### **Why is there an application fee?**

Each application we receive requires a \$20 processing fee. This fee is used to cover the costs of verifying the application and obtaining credit reports. Besides covering our costs of processing, this fee shows that you are seriously interested in our rental property.

### **Is the application fee refundable?**

In the event we approve another applicant and rent the property that you have applied for before your application is processed, we will provide a refund of the application fee. Once we start processing your application this fee is non-refundable.

### **Do you allow pets?**

We do allow pets in most of our rental properties with written permission. Pets may be subject to additional security deposits. Please ask your Oklahoma Property Network representative for more information.

### **Do you provide appliances?**

We generally provide a stove and refrigerator if needed. These appliances are provided as a convenience and not included in rent. In some cases we may offer appliance upgrades. Of course you can provide your own appliances including washer and dryer where applicable. Please ask your Oklahoma Property Network representative for more information.
